

OFFICIAL RULES FOR SEINFELD SWEEPSTAKES W/ BIG 105.9

NO PURCHASE NECESSARY.

HOW TO ENTER: This Sweepstakes begins on 11:00 pm ET Monday, **MARCH 11, 2019** and ends 12:00 am ET Friday, **MARCH 15, 2019** (“Sweepstakes Period”).
